This privacy policy ("Privacy Policy") explains how we collect, use, share and protect personal information about the Users of the Services, including the Practitioners (as defined in the Terms of Use), the End-Users (as defined in the Terms of Use), and the visitors of Website (jointly and severally referred to as "you" or "Users" in this Privacy Policy). We created this Privacy Policy to demonstrate our commitment to the protection of your privacy and your personal information. Your use of and access to the Services is subject to this Privacy Policy and our Terms of Use. Any capitalized term used but not defined in this Privacy Policy shall have the meaning attributed to it in our Terms of Use.

1. WHY THIS PRIVACY POLICY?

This Privacy Policy is published in compliance with, inter alia:

- i. Section 43A of the Information Technology Act, 2000;
- ii. Regulation 4 of the Information Technology (Reasonable Security Practices and Procedures and Sensitive Personal Information) Rules, 2011 (the "SPI Rules"); and
- iii. Regulation 3(1) of the Information Technology (Intermediaries Guidelines) Rules, 2011. This Privacy Policy states the following:
 - a. The type of information collected from the Users, including sensitive personal data or information;
 - b. The purpose, means and modes of usage of such information; and
 - iii. How and to whom Lantern Health Services Pvt. Ltd. will disclose such information.

2. COLLECTION OF PERSONAL INFORMATION

Generally, some of the Services require us to know who you are so that we can best meet your needs. When you access the Services, we may ask you to voluntarily provide us with certain information that personally identifies you or could be used to personally identify you. Without prejudice to the generality of the above, information collected by us from you may include (but is not limited to) the following:

- i. Contact data (such as your email address and phone number);

- iii. Physical, physiological and mental health condition;
- iv. Sexual orientation; v. medical records and history;
- v. Biometric information;

- viii. Call data records. Information that is freely available in the public domain or accessible under the Right to Information Act, 2005 or any other law will not be regarded as personal information or sensitive personal data or information.

All the statements in this Privacy Policy apply to all Practitioners, and all Practitioners are therefore required to read and understand the privacy statements set out herein prior to submitting any sensitive personal data or information to Lantern Health Services Pvt. Ltd., failing which they are required to leave the Services, including the Website immediately.
- iii. Practitioners' personally identifiable information, which they choose to provide to Lantern Health Services Pvt. Ltd. is used to help the Practitioners describe and identify themselves. This information is exclusively owned by Lantern Health

Services Pvt. Ltd. Lantern Health Services Pvt. Ltd may use such information for commercial purposes and in an aggregated or non-personally identifiable form for research, statistical analysis and business intelligence purposes, and may sell or otherwise transfer such research, statistical or intelligence data in an aggregated or non-personally identifiable form to third parties and affiliates.

Lantern Health Services Pvt. Ltd. also reserves the right to use information provided by or about the Practitioner for the following purposes:
